Sub:- School Education Department – Inter District Transfers of teachers working in Government / Zilla Parishad/ Mandal Praja Parishad on spouse/ mutual grounds – Further Information – Instructions Issued - Regarding.

2. Online applications by the teachers.
3. Reports received from the District Educational Officers.

All the District Educational Officers in the State are informed that applications from the teachers working in Govt./MPP/ZP is called for considering the Inter District Transfers in accordance with the provisions contained in Rule 5(2)(c) and 5(2)(d) of Andhra Pradesh Public Employment (organization of Local cadres and regulation of Direct Recruitment) Order 1975.(Spouse/Mutual grounds) with instructions that:

- The teachers shall apply online for Inter District Transfers in the IP address prescribed for the purpose i.e. **cse.ap.gov.in**
- In addition, the candidates shall also download application form, fill up and sign give to the concerned Mandal Educational Officers. (This is only for verification – Hard copies are not processed for transfer).
- The Mandal Educational Officer concerned should verify all the details / particulars with original records and certificates and after satisfying their correctness they shall submit to the District Educational Officer.
- The District Educational Officer concerned shall forward the applications of the teachers in the prescribed proforma issued in Government Circular Memo.No.7232/MC-I/GAD/2011, Dated:04.08.2011.
- The District Educational Officers are also requested to confirm the applications through online and submit hard copies with detailed remarks on each request.

- (a) Most of the Mandal Educational Officer/Dy. Educational Officers have not counter signed the certificates furnished by the teachers.
- (b) Most of the District Educational Officers have also not submitted the applications of the teachers in the prescribed proforma issued in Government Circular Memo.No.7232/MC-I/GAD/2011, Dated:04.08.2011.
- (c) Detailed remarks/recommendations are not given by the District Educational Officers in many of the case.
- (c) Remarks/reasons on the applications which are not confirmed by the District Educational officers are not specifically given.

Therefore, all the District Educational Officers in the State are instructed to:

- (i) To furnish specific remarks/reasons on the applications which are not confirmed by the District Educational Officers?
- (ii) Furnish the details of each applicant in the proforma issued in Government Circular Memo.No.7232/MC-I/GAD/2011, Dated:04.08.2011 duly signed.
- (iii) Depute one Assistant Director or Deputy Educational Officer to counter signed the certificates furnished by the applicants (the shall come with full details/official stamp etc.,) on 11.02.2016.
- (iv) The Deputed Officer shall also bring the details of applicants in the GAD proforma on 11.02.2016.

The above instructions shall be followed scrupulously.
