The Hon'ble CM has reviewed the Implementation of Employees Health Scheme in detail and the following decisions were taken.

- 1. The total project cost for implementation of the Employees Health Scheme is estimated at Rs. 400 crores per annum. The Employees Unions have agreed to contribute 50% (Rs.200 crores) towards this.
- 2. The representatives of ASHA and CEO, NTR Vaidya Seva Trust will work out revised package rates under Employees Health Scheme which is reasonable just and mutually agreeable. They shall complete this exercise in a maximum period of 6 weeks. Advisor to Govt., Medical & Health will be consulted along with the other experts during the conduct of this exercise.
- 3. The Employee Health Scheme shall be implemented with immediate effect by the hospitals. ASHA will issue directions to their network of hospitals immediately in this regard. The scheme shall begin from 16th January, 2016. The package rates from 16th January, 2016 will be as per the revised rates decided by the CEO, NTR Vaidya Seva as well as representatives of ASHA and will be implemented with retrospective affect from 16.01.2016. The employee Unions have also agreed that the employees share of 50% will also be implemented with retrospective effect from 16.01.2016.
- 4 (a) It was ordered by the Hon'ble Chief Minister that the contribution of the Employees under the Employee Health Scheme will be parked with the NTR Vaidya Seva Trust in an account separately created for the said purpose and will not be with Finance Department. This order will come into force with immediate effect.
- (b) The recoveries from the employees and pensioners made by the DTA, PAO and other agencies etc shall be transferred to the AHCT directly by the DTA / PAO every month by 15th with effect from January, 2016 Salaries.
- (c) Necessary instructions will be given by the Finance Department to ensure that the operation of PD Account for the Employee Health Scheme is simplified such that the payments can be made to the hospitals within 15 daysof the submission of the duly scrutinized bills.
- (d) The share of Govt. will paid quarterly by the finance Dept. to NTR Vaidya Seva Trust.

The available amount at present of the employee contribution to the Employee Health Scheme with Finance Dept. will be transferred to the NTR Vaidya Seva Trust immediately.

5. The Finance Department shall give access of all eligible employees and pensioners data to the NTR Vaidya Seva Trust. The teachers data relating to

Municipal Corporations of Visakhapatnam and Kurnool should also be shared with NTR Vaidya Seva Trust by Finance Department, immediately.

- 6. It was agreed that separate Management Committee within the NTR Vaidya Seva Trust will be constituted to monitor the implementation of the Employee Health Scheme which will have representatives from the recognised Employees unions.
- 7. As the Employees Health Schemes is still to be stabilised, the medical reimbursement scheme and the EHS Schemes will run parallel upto 31.03.2016.
- 8. The Steering Committee under the Chairmanship of Chief Secretary to Govt., will ensure timely implementation of these decisions. The Steering Committee will review the scheme from time to time and ensure its effective implementation and is authorised to take all decisions to implement the scheme effectively.
